



Health and Safety Overview/Updates

- Masks: All students/staff will be required to wear facial coverings regardless of vaccination status (we will be taking mask breaks outside when possible)
- 2. Students & teachers will maintain 3ft distance as much as possible throughout the day
- 1. All students will be offered weekly COVID-19 testing, regardless of vaccination status beginning the 1st week of school
- 2. Weekly COVID-19 testing is also being offered to all staff



- 5. CPS is now requiring employees be fully vaccinated. Anyone with an approved exemption will be required to test weekly. Staff have until Oct. 15th to comply
- 6. Lunchroom: Students will continue to have lunch with a reduced number of students
 - a. There will be continued cleaning/disinfecting in between lunch periods
 - b. Classrooms will continue to have designated spaces in the lunchroom
- 7. Recess: Students can intermingle at recess with other classes, but must remain masked during that time.

Health & Safety contd.

- 8. Health Screeners: Health screeners are still required, but temperatures will no longer be taken.
- 9. Care Room: We will continue to have an established care room where any students who are showing symptoms of COVID 19 will go and wait for pick up which MUST be ASAP. Students will not be permitted to ride the bus.
- 10. Volunteers: There will still be no parents/guardians/volunteers allowed in the building. This may be revisited or shifted later in the year

District Priorities

District Priorities Overview

Social Emotional Learning: Our need for SEL connection has never been greater & we must affirm our commitment to collective wellness.

School Counseling & Transition Supports: A major goal is to prepare for postsecondary success defined by personal and relational wellness, civic engagement and socio-economic advancement.

Academic Intervention & Tutoring: Tier 2 and TIer 3 interventions *in addition* to core instruction can close academic gaps. Schools must identify students in need of additional academic support & provide interventions.

Learning Acceleration: We must ensure all students have learning experiences that are anchored in grade-level standards, quality curricula, meaningful formative assessment and responsive, culturally-affirming instruction.

Diverse Learner Supports: Students with persistent reading challenges are in need of more intensive interventions or specialized services.



Sick Student Protocol

If a child is sick or displaying covid-19 symptoms:

- The teacher/staff will buzz the main office and let them know
- 2. A staff member will escort the child to the care room & then call home
- 3. The care room attendant will take their temperature, log their symptoms and monitor them until they are picked up. Students will not be allowed to ride the bus.

Students sent to the care room must be picked up immediately

COVID-19 Exposure Protocol

If there is a positive case within a pod, the positive case must submit a report to cps.edu/covidresults

If students are quarantined, they will remain home. They will not be able to join the CPS virtual academy.

Morning Entry

Earliest Drop Off: 8:45 am

Tardy: Arriving after 9:15 am: Enter through the main entrance

Parents will not be permitted to stay on the playground or field in the morning. No parents/guardians will be allowed in the classrooms. Further guidance will be shared closer to second quarter.

Student Dismissal

Pre-K will be dismissed at the Pre-K door

K-2 students will remain with their homeroom teacher as they are escorted to the bus If you pick up your child, please let the teacher know.

3-8 will leave in a staggered manner and students should go directly to their bus
We will NOT accept any calls to tell students "not to get on a bus." You MUST be at school at 4 p.m. and can remove your child from the bus
ALL guests and parents should be wearing masks when on school property

Technology

Students will have access to technology throughout the school day but individual devices will NOT be assigned to students outside of the classroom.

We strive to limit the amount of student screen time while in the building whenever possible.

Non-CPS devices are NOT permitted in school.

Sports

We plan to offer Fall Sports. Mr. Rezek will send details during the second week of school.

Unvaccinated athletes in grades 5-8 must engage in weekly Covid testing during their sports season
